Registration

Registration process:

- Domain registration is requested via RCP or API.
- Two or more nameservers must be configured and return an authoritative answer before the domain is requested.

Transfer

- Domain transfer is requested via RCP or API.
- Domain need to be unlocked and auth code is required for transfer.
- Two or more nameservers must be configured and return an authoritative answer before the domain is requested.

Outgoing transfer

Once the transfer is initiated at the new registrar, the transfer needs to be approved manually by us.

Update

Owner change (trade)

- **Trade** - not supported for this TLD

Other update

- **Handle updates** - not supported
- **DNS zone updates** - via RCP and API. Not real-time. Update can take 6-12 hours to complete
- **Nameserver updates** - via RCP and API. Not real-time. Process is manual, can take up to 2 business days to complete

NB: Error message like `Domain update failed: E0102, Domain could not be updated., Identical task is already being processed` means previous update is not finished yet

Deletion / Restore

Delete

- **Delete** - via RCP or API.
Once the domain is deleted, it goes directly to Hard Quarantine, hence if you need to keep the domain ACTIVE, make sure that the Auto Renew is ON.

Restore / reactivate

- **Restore** - domain will no longer be visible in control panel after expiration. A restore via control panel and API are not supported for this TLD. If you wish to restore a .com.tr domain after expiration (within 30 days after expiration), please contact our [Support Team](#) to check if your domain can be restored manually.
- Once the domain is expired, it will be available after **3 MONTHS** for re-registration.
