If you use this trustee service, the .kz domain name can only be used for webforwarding and e-mail-forwarding but not in the regular way due to this regulation. • Please send us a domain name (and an e-mail-adress) where the .kz domain name should forward to.

Registration agreement	<i>The registry requires that a registration agreement is in place between the provider and the domain holder. The text of this registration agreement and any required supplements is the following:</i> • General registration agreement
