Registration

Registration process can take up to 10 business days to complete

Authorization code required	yes

Update

Owner change (trade)

- **Trade** - via RCP or API, by updating the owner handle. Process is manual, contact Openprovider support to finish the operation

Other update

- Changes in nameservers or handles can take upto 10 days to process.

Deletion / Restore

Delete

- **Delete** - via RCP or API. Deletion application form must be signed and sealed by domain owner. Process is manual, contact Openprovider support to finish the operation

NB: once domain is deleted or expired, registry doesn't provide ETA within which it will be available for registration again

Restore / reactivate

- **Restore** - not supported for this TLD
