

# .pe

This article describes the procedures and requirements of .pe domain names.

## Registration

A .pe domain name registration is realtime and requires no specific additional data outside of the regular contact details for the owner, administrative and technical contact.

Please note that the nameservers must be configured and return an authoritative answer before the domain is requested.

## Transfer

To transfer a .pe domain name please make sure to first get the authorisation code from the current registrar. Using this code you can request the transfer through our website. The transfer will complete instantly and the domain name will be available in your account immediately.

## Update

# Owner change (trade)

A change of ownership can be done by replacing the owner contact in the control panel. After saving the changes the change is processed realtime. It may take up to 24 hours for the whois to update.

# Other update

A change of contact details can be done by updating the associated handles in the control panel. After saving the changes the domain name will be updated realtime. It may take up to 24 hours for the whois to update.

## Deletion / Restore

# Delete

A delete is realtime. After a delete the domain will be available for registration immediately.

# Restore / reactivate
